## **BACKGROUND AND CONTEXT**

# Nishnawbe Aski Nation

Nishnawbe Aski Nation ("NAN") is a political territorial organization representing 49 remote First Nation communities within northern Ontario. The total population of membership of NAN First Nations, including on and off reserve members, is estimated to be at least 45,000 people. Many of the 49 First Nations within NAN do not have year-round road access, and even among those who do, many health and social services are not available or accessible. Remoteness impacts First Nations ability to provide services in community. NAN is a national leader in the work to quantify the additional costs associated with service delivery in remote First Nations to achieve needs-based fundings.

# Social Services Strategic Advancement Department

The Social Services Strategic Advancement Department provides advocacy, coordination, strategic planning, and support to assist NAN First Nations and Tribal Councils to achieve their goals. The department interfaces with the federal, provincial, and municipal governments in its advocacy role. The work involves negotiations, policy development, program implementation and evaluation. A key priority is ending discrimination for NAN members and promoting substantive equality in social services related funding, policy, and legislation. The department recently expanded to support the successful implementation of long-term reforms with respect to child welfare and child and youth mental health in NAN First Nations.

## **OBJECTIVE**

NAN is seeking a qualified, reputable, highly skilled, and very experienced individual with expertise in policy development, engagement, strategic planning and the development of communication and briefing materials. Experience working with provincial and federal governments is an asset, as is working with First Nations. The individual will participate in the work of the department while building the capacity (knowledge, skills, and abilities) of the policy analysts and managers in the department.

#### PROJECT TIME FRAME

The work shall be conducted between May 15, 2024, and March 15, 2025. The consultant is required to work full time (35 hours a week minimum). Travel is required, which can result in additional hours.

# **LOCATION**

It is preferred that the consult reside in Thunder Bay, Ontario for the duration of the contract. However, a hybrid of in person and virtual may be considered.
